This agreement represents a formal working document between INNOVATIVE PLASTICS INC. and CO2 Lasers Caucasus Ltd (19 app. 326 house, 3A Varketili) related to distribution of Laserable Plastics materials. The following issues related to sales and service representation of INNOVATIVE PLASTICS INC. materials:

Purchase Orders and System Manufacturing

Upon sale of a product, CO2 Lasers Caucasus Ltd (19 app. 326 house, 3A Varketili) will submit a purchase order (P.O.), which will include **customer's contact information**, an itemization of the products and materials. Upon receipt of a P.O., INNOVATIVE PLASTICS INC. will place the pro forma. The method of payment is by Letter of Credit or in advance. Delivery of products is variable, with every effort made by INNOVATIVE PLASTICS INC. to deliver products and materials within a reasonable time frame.

Payment

All payments are to be made on account indicated in the pro forma invoice sent by INNOVATIVE PLASTICS INC. via e-mail or priority mail.

Freight & Insurance

Freight and insurance for all products shipped to international locations can be arranged by INNOVATIVE PLASTICS INC. if the distributor requests. Freight and insurance charges will be billed to the international customer as a separate line item on the INNOVATIVE PLASTICS INC.'s invoice. INNOVATIVE PLASTICS INC. will invoice the freight and insurance costs at the discounted price that INNOVATIVE PLASTICS INC. receives from the shipper. If a distributor arranges freight and insurance, the equipment must be paid in full by wire transfer before the equipment leaves the INNOVATIVE PLASTICS INC. warehouses.


